The neurosurgery was aimed at spinal decompression and at the surgical treatment of head injuries. This was to enable competence in head flaps and neurosurgical decompression as well as other paediatric procedures.

Senior Registrar in Orthopaedic Surgery, Royal Naval Hospital, Haslar, Gosport, Hampshire under Surgeon Captain Bertram, Surgeon Commander Osborne and Surgeon Commander Farqharson-Roberts November 1988 – December 1989. This included organising the Department and covering for absent consultants. Major interests were spinal and knee surgery. The Department had gained a knee signature system machine for the measurement of knee ligament instability. Trauma from both the Services and civilian life were admitted via the Accident and Emergency Department. The spinal surgery was taught by Captain Bertram and by Commander Farqharson-Roberts. I was able to do single handed disc surgery and assist at the more complex procedures such as fusions.

### **ORTHOPAEDIC SPECIALIST AUSTRALIAN ARMY:**

Emigrated to Ingleburn, New South Wales to 1<sup>st</sup> Field Hospital, December 1989 to August 1990 as a Lieutenant Colonel RAAMC. Worked both single-handedly at I Field Hospital and with Dr Robin Higgs at Concord, Repatriation Hospital. I engaged in arthroscopic and knee reconstructive surgery for the Army and in joint reconstruction with Dr. Higgs. I was also utilised in covering the Accident and Emergency Department in both Concord Hospital and the Military Hospital. I continued to perform lumbar disc surgery.

Also at this time I attended the local orthopaedic training program for Australian Registrars.

### **SENIOR REGISTRAR:**

Returned to the U.K. as Senior Registrar and Lecturer in Orthopaedic Surgery at Southampton General Hospital. August 1990 to August 1992 rotated through training posts:

Under Professor Shearer and Mr. Woods specialising in joint replacement and rheumatoid surgery. This was also the lecturer's job and much time was spent in giving formal lectures and in tutorials to smaller groups. Trauma cover was provided as well as outpatients and elective surgery. I lectured in spinal surgery to the Wessex General Practitioners.

Under Mr. Fitzgerald specialising in hand surgery and as trauma manager, responsible for the organisation of trauma services in Southampton General Hospital. This amounted to organising and performing some of the surgery on patients admitted via the Accident and Emergency Department – some 12 to 15 cases per day. During this time I gained experience in the surgery of the fractured spine and the fractured pelvis. The surgery of the pelvis was initially learned at the London A/O pelvis course. The surgery of pedicle screw implantation was learned by local teaching leading to proficiency in spinal fracture and tumour stabilisation. I was also responsible for carrying out and supervising the surgical management of a host of other fractures including the use of nailing, plating and external fixation techniques.

Under Mr. Jackson and Mr. Robertson specialising in spinal surgery and knee surgery. Scoliosis surgery and knee reconstructions were the major interests. Further experience was gained in spinal fixation and decompression. Anterior spinal approaches including trans-thoracic and trans-abdominal were taught.

Under Mr. Clarke and Mr. Harley specialising in joint replacement, spinal surgery and paediatric surgery. Mr. Harley specifically taught me initial spinal trauma management along with the various spinal approaches. Under Mr. Clarke the use of ultrasound as a diagnostic tool was taught along with paediatric surgery.

#### **CONSULTANT IN ORTHOPAEDIC SURGERY:**

Returned to Brisbane in August 1992 as the Consultant Surgeon to 1<sup>st</sup> Military Hospital, Yeronga. During this time I was the only orthopaedic surgeon in the Australian Defence Force. I organised my own rota and carried out outpatients with cold and emergency surgery. I performed spinal surgery, general orthopaedic procedures, trauma and knee ligament reconstructive surgery. I worked as the relieving Orthopaedic Surgeon at the Royal Brisbane Hospital from December 1992 until December 1993. This was to carry out one session of outpatients and one session of operating per week. During this time I was responsible for carrying out trauma and elective surgery and also for supervising the registrars on my patients. I resigned from the Army in December 1993.

I then became involved in full time private practice in Brisbane. I operated twice a week in a variety of private hospitals. About 50% of my elective surgical cases were spinal. I regularly performed lumbar discectomies, spinal decompressions and instrumented spinal fusions. This instrumentation was via pedicle screws or interbody threaded cages utilising either PLIF or anterior approaches. I also carried out a large number of arthroscopies and knee ligament reconstructions. Joint replacement and shoulder surgery was also performed.

To pursue my spinal interests I spent some time with Dr. Henri Graf in Lyon and hosted him in Brisbane where I organised a number of meetings on the Graf technique. I also went to Toronto to a spine challenge meeting where I learned endoscopic discectomy techniques among many other approaches.

I was elected to the Faculty of the Australian Society of Musculo-Skeletal Physicians due to my interest in spinal conditions and was a Senior Lecturer at the University of Queensland.

Trauma cases were referred via GP's, public Accident and Emergency Departments and private Accident and Emergency Departments. I was on continuous emergency call via my pager on a one in three rota for both the Mater Misericordiae Private Hospital and St. Andrew's Hospital, which both have their own Accident and Emergency Departments and for the North West Private Hospital.

I had visiting rights at St. Andrews War Memorial Hospital, Holy Spirit Hospital, North West Private Hospital, Mater Private Hospital, Wesley Hospital, and Strathpine Private Hospital. These are all hospitals in Brisbane.

I returned to the UK in 1996 to take up an NHS post as a consultant in orthopaedic surgery with an interest in spines at the East Somerset NHS Trust. This included the entire range of orthopaedic conditions including trauma. During this time I expanded my interest in spinal disorders by attending regular meetings with Peter Webb at Taunton. As a result I applied for consultant posts in spinal surgery.

In 1998 I took up a post as a full time spinal surgeon at Frimley Park Hospital. This was in a unit of two full time spinal surgeons. Trauma surgery was still performed on the duty rota. I was dealing with spinal surgery and non-operative pain relief to the cervical, thoracic and lumbar spines. This included spinal trauma, tumours, deformity and infection. Emergency spinal conditions were referred from all around the South of England. I hosted regular spinal meetings in Frimley.

## **RESEARCH INTERESTS**

I have designed, written the technique and indications for use of a long stemmed, cannulated, lockable prosthesis, which is presently in use in the U.K. The prosthesis is manufactured by Orthodesign in Christchurch under the name of CANNULOK. It was not imported into Australia and therefore I have not been able to provide much research on it. It is designed to deal with fractures below implants via a closed technique but has several more applications. It has been presented at the British Orthopaedic Association by Orthodesign. It gained the 'Winning by Design' Award in 2002.

The use of Graf Banding technique in spinal instability. I have a personal series of over 200 cases. I have lectured extensively on its use.

The use of epidurals in spinal pain, which is both an audit project and a research project and which was presented at Britspine.

I specialise in investigation, assessment, treatment and management of spinal disorders. Although I have over 25 years of extensive surgical experience I no longer perform open spinal surgery and have not done so since April 2013. My main focus is now pain management and non-surgical intervention, carrying out procedures such as facet joint blocks, nerve root blocks, radio frequency denervation, lumbar epidurals, nucleoplasty and prolotherapy.

I am committed to education and regularly organise Spineworks meetings for GP's and allied health practitioners such as nurses, physiotherapists, chiropractors and osteopaths.

I attend courses throughout the year in keeping with revalidation and continuing practice development. Specifically I regularly attend the multi-disciplinary team audit meetings at Frimley Park NHS Hospital, Frimley, Surrey.
